## Gayle Weisfield to Teach 3-Day Spring Workshop Apr. 13-15, 2011

GAYLE WEISFIELD ([www.gayleweisfield.com](http://www.gayleweisfield.com)), is an accomplished artist, talented instructor, world traveler, and passionate student of life. She is best known for her work as a realistic landscape painter. Her subjects range from the natural scenery of the Columbia River Gorge where she was born and

now resides, to the architectural beauty found in Thailand, Rome, and beyond. Working primarily in transparent watercolor, she uses a fresh, direct, wet-in-wet technique with strong design and bold value patterns. Gayle avidly believes that everyone is an artist, and is enthusiastic about and committed to teaching workshops for all skill levels. She has taught hundreds of students over the last thirty years, and has developed many successful methods for unleashing creativity. She has been a Signature Member of the Northwest Watercolor Society since 1980.

In our spring workshop, Gayle will teach, among other things, a wet-in-wet technique on paper stretched on boga board stretchers, and show how to read the moisture content of the paper in order to apply multiple layers of colors with controlled edges, developing a new subject and painting in class each day.
