Bylaws change to affect the date when dues late fees kick in

A proposal to change the SWWS bylaws was recommended by the Board of Directors. Notification was sent out to membership 30 days prior to the vote that was taken at the August 12th SWWS picnic, meeting and AHA.

A unanimous vote was accepted by president Will Ray to change Article 4, Sections 2 and 4 of the bylaws, changing the late fee date from April 1st to Feb 15th. The purpose of this bylaw change is to speed up the intake of membership renewals so that more complete and up-to-date lists of eligible members can be ready in better time for spring workshops and show entries.



On August 5th, William "Bill" Brake, husband of Lynda Raven Brake, passed away peacefully after three months of knowing about bladder cancer that had spread to his spine. A Celebration of Bill's Life will be on Saturday, September 23rd, starting at 10:30 a.m. with lunch provided for time to visit. The art communities of the Southwest Washington Watercolor Society, Art Adventures and Oregon Society of Artists that received Bill's help in hanging shows, hauling art panels and whatever else was needed at all art adventures, will be part of the celebration. Also, the environmental communities of the Sierra Club and the Columbia River Keepers that Bill worked tirelessly with as a technical advisor against the oil terminal, coal trains, methanol plant in Kalama and many different fossil fuel projects in Longview, will also be honoring Bill's life and work. Bill had asked everyone from both communities to paint rocks representing the environment of the Northwest. He had become

very happy painting rocks with visitors to his home from South Dakota, New Mexico, Chicago, New York and Southwest Washington. His rocks keep coming and will be at the celebration. Bill would be thrilled that his rocks are continuing to represent the beautiful Northwest. The Celebration will be held among the trees, birds and animals that he loved at the residence of Don and Alona Steinke at 4833 N.E. 238 Ave. just off WA-500. Directions are below. Provisions to stay dry will be made in case of rain during the celebration and lunch. Join this celebration of a man most of you have worked with or seen working at our art shows and many other art events. The day he went into the hospital was just after helping Lynda pick up her artwork that she had in the Spring Show at Boomerang.

DRIVING INSTRUCTIONS

Carpooling might be a good idea as parking might be a bit of a problem. Alona and Don Steinke's home is located at 4833 N.E. 238th Ave., Vancouver, WA 98682. Their telephone is 360-892-1589 and their email is: crvanwash@gmail.com. (NOTE: Don't use GPS navigation or Google Maps for the last mile. The ambulance couldn't find it using those tools.)

From Salmon Creek: Get on I-205 southbound and take Exit 32 for Padden Pkwy.

TL onto N.E. Padden Pkwy. and go 4.4 miles continuing onto N.W. Ward Road.

TR onto N.E. 162nd Ave. and go 0.9 miles.

TL onto WA-500 E/NE Fourth Plain Blvd. and stay on Fourth Plain/SR500 for 3 miles. The road will make 3 right angle turns so you will end up facing south. Stay on SR500 for 1300 feet until the road makes a swish

TL into their driveway at the blue farm stand. Their home is 700 feet back.

For Vancouver residents: The Steinkes live on Fourth

Plain about 7 miles east of Orchards, except the road gets renamed at every bend. After the road makes three right turns, continue 0.26 mile to 4833 N.E. 238 Ave.

TL (east) into the driveway at the blue farm stand. Their home is 700 feet back.

From Portland via I-5 north into Washington:

Take Exit #1A to merge onto WA-14 E toward Camas (about 9.9 miles).

Take Exit #10 for S.E. 192nd Ave. and go about 0.2 mile. TL onto S.E. 192nd Ave. and head north 3.4 miles on S.E 192nd. (The street numbers go down, before they go up.)

TR onto N.E. 13th St. and go about 0.5 mile. Continue onto N.E. Goodwin Rd. and go about 0.8 mile. Continue onto N.E. 28th St. and go about 1.5 miles.

TL onto N.E. 242nd Ave./WA-500 W and continue to follow WA-500 W around two bends, about 1.1 miles to 4833 NE 238 Ave. Turn into the driveway at the blue farm stand. Their home is 700 feet back.

Please be sure you have paid your current 2017 dues prior to entry. You may enter four paintings, however we may not be able to hang all four. Number them in the order you want them hung. We recommend that you register as soon as possible, since the number of entries we can hang will be limited by available space. First come, first served by the date received. The registration form can be found in this newsletter and will be sent via email and/or regular mail to all SWWS members and also will be on the SWWS website.

TIMELINE FOR SHOW

Registration: September 1-September 22

Art Take-In: Saturday, September 30, 12 Noon-2 p.m.

Show Dates: October 2–October 27

Art Pick-Up: Saturday, October 28, 10 a.m.—Noon First Friday Reception: October 6, 2017, 5 p.m.—9 p.m. Artist Awards Reception: October 6, 2017, 7 p.m.—9 p.m.

INSTRUCTIONS:

No entries will be accepted after September 22. Entry fees will be due at Take-In on September 30.

- 1. Read the prospectus requirements carefully. Pay special attention to framing requirements.**
- 2. Make sure you are eligible for the show by paying your 2017 dues.
- 3. Complete the registration form for one to four entries. List art in your order of priority for hanging.
- 4. Check the box indicating that your entries meet the requirements and sign the document to acknowledge compliance.
- 5. Submit form by email to: cmcw@nwlink.com or mail to: SWWS Fall Show, 6325 N.E. Lessard Road, Camas, WA 98607.
- 6. You will receive notice when registration is received.
- 7. Do not submit entry fees. Fees will be collected at Take-In.
- 8. Art Take-In: Bring your art to Boomerang, 808 Main St., Vancouver on Saturday, September 30 from Noon to 2 p.m. Entry fees will be collected at that time with payment by cash or check. You will receive a signed copy of your registration and a receipt for your fees to serve as your claim form.

**All paintings must be ready to hang. There will be no wire station available.

An interview with Barbara Van Nostern, new Lifetime Member

On the "First Friday" in July, the SWWS surprised Barbara Van Nostern by honoring her with the Lifetime Member Award. We served up treats on this beautiful July evening outside of Rand Jewelers, where Barbara shows her work. Friends and the community stopped in to honor and congratulate her. Recently I was able to sit with Barbara to learn more about this extraordinary woman and her love of watercolor.

Q. Can you tell us a little bit about your background?

Raised in Superior, Wisconsin, Barbara never attended art school. Her mother was an art teacher, and when Barbara was in high school her mom was her substitute art teacher, which pleased Barbara. She learned from her mom and from her sister, who is also a watercolorist and art teacher.

Once when they were out at Bickelton, WA, she and her sister sat in the middle of the highway to paint a barn and old car—grey and weathered—but she found all these lovely colors. She was hooked from then on.


In 1980 she started at Clark College and graduated in 1985 with a degree in Psychology and Art. She wanted a degree in Art Therapy, but that didn't come to pass. She worked as a key punch operator, first at J.K.Gill, then at J.C.Penney and finally at Consolidated Freight. She has three sons, ten grandchildren and five great-grandchildren, and lives in Vancouver with her husband Dean.

Q. Did you have someone who took an interest in your artwork, or who inspired you when you were young?

A. My mother, sister, and my high school art teacher.


Q. Do you remember a drawing or a painting you did as a child that you thought was pretty great?

A. It was a cowboy wearing a vest and a cowboy hat.
The cowboy even had

A. Many of my art friends. I was in art class with Patti Meuler, had classes with Susie Cowan, and members of SWWS. We learn from each other.

Q. What do you prefer to paint?

A. Anything that hits my soul. People, I love to find expressions...old people...young ones. I love to paint old cars; rusty ones to shiny show cars...and flowers in the spring!

Q. What moves and motivates you as you paint?

A. I see beauty in things and I want to paint and express them. The beautiful flowers, leaves and antique cars. Things, they hit my soul and I have to paint them.

Q. What is one habit that has contributed to your success?

A. Seeing beauty in everything. I see color even in old rusty cars. I do a lot of sketching and carry a sketch book with me, plus I do value studies.

Q. What inspires you?

A. Beauty...Color...People...Old Cars. I was brought up to see beauty in everything, especially color. Mother would say, "Oh look at that ultramarine blue water," or, "Look at that alizarin crimson sky!" We always talked in color.

Q. Is there a painting of your own that you would never part with?

A. Yes. "Mystical Canyon" from a workshop called "Each One Teach One."

Q. If you could have a piece of art from one artist who would it be?

A. I have a collection of national and regional artists hanging all over my house. I only have one of my own paintings in the house at this time, and I rotate paintings often.

Q. How long have you been a member of the

SWWS and what have you enjoyed about being a part of the Society?

A. I joined in 1984. I have enjoyed the wonderful people and the lovely paintings. It fulfills you. They (SWWS members) inspire me to go home and paint. Take workshops! We learn so much, not just from the teacher but from each other. If we learn just one thing, the workshop was a success.

Barbara has been as active member of the SWWS for 33 years, and during that time she has been president three times and secretary two times, and was a founding member of Gallery 21 at 1013 Main in Vancouver which closed in July of 2009 after 21 years.

She has won numerous awards in local, regional, national and international exhibitions. She is a signature member of the Northwest Watercolor Society, the San Diego Watercolor Society, the Red River Watercolor Society, and the Montana Watercolor Society. She has taught watercolors through the schools and different art organizations. She presently gives classes in her studio.

Jury Up coming in September

The opportunity for associate members to be juried into full active membership is coming to you on September 13th in time for you to be able to enter the Fall Show this year. Leading up to that date, there will be an AHA on September 9th to critique paintings that you may want to bring in for possible improvement ideas.

Associates wishing to be juried may submit three paintings, two of which must be transparent watercolor. The other submission may be either transparent watercolor or water media. All paintings must be framed, but they do not have to meet the framing requirements for the show. Other than framing, all paintings must adhere to the requirements in the Fall Show prospectus:

"Paintings must have been executed within the past two years and not previously shown in any other SWWS show. All paintings must be the original work of the submitting artist: no copies or likenesses of other artists' or photographers' works. This includes, but is not limited to, images from books, magazines, calendars, greeting cards, catalogs, and the internet. Exception is made for use of photographs from friends and family."

To submit paintings, please call Fall Jury Chairman, Marilyn Salter at 360-721-5285 to arrange a time to drop them off at her home between Sunday, September 10th, and Tuesday, September 12th. At the time of submission, applicants will fill out the application form and pay the \$10.00 jury fee (CHECK ONLY), which is refunded if the applicant is not juried.

On Wednesday, September 13, five judges will meet to evaluate the submissions. A letter will be mailed advising applicants the results and paintings may be picked up. If you have questions, please call Marilyn at the telephone number shown above.

SWWS MEMBER PAGES

The SWWS is pleased to provide "Member Pages" to our juried members. If you would like to be included on this page, please follow these simple guidelines.

- 1. Provide your biography in a Word document.
- 2. At the end of your bio, please list the names of your paintings, as you want them to appear on your web page.
- 3. Please indicate which of your paintings you would like shown under your name as a profile picture, on the "SWWS Members Page."
- 4. Send up to eight photos of your paintings to be displayed on your member page.
- 5. Send a photo of yourself.

PHOTO REQUIREMENTS

When you are saving your photos, the dimensions should be no larger than 1000 pixels on the longest side. Please save this image at a resolution of 72 pixels/inch.

Save your image files as .jpg.

It is important that the name you use when saving your image file is the same name you use in your word document when listing the titles of each painting you are showing. ONLY letters & numbers may be used in the image file name. Do not use special characters such as ?, >, <, ", ', &, %, etc.

Registration: Sept. 1–Sept. 22. No entries accepted after Sept. 22, 2017.

Art Take-In: Sept. 30, 12 noon-2 p.m. Entry fees collected.

Show Dates: Oct. 2–Oct. 27

Viewing Hours: Mon.–Thurs., 8 a.m.–5 p.m.; Fri., 8 a.m.–9 p.m.; Sat., 9 a.m.–4 p.m.

First Friday Reception: Oct. 6, 5 p.m.-9 p.m. during Art Walk

ELIGIBILITY:

- SWWS juried members who have paid their current dues.
- Watercolor or watermedia paintings must have been created within the past two (2) years and not previously shown at an SWWS show.
- Paintings must be original work of the submitting artist. No copies or likenesses of other artists' or photographers' works are acceptable. (NOTE: This includes, but is not limited to, images from books, magazines, calendars, greeting cards, catalogs, and the internet. Exception is made for the use of photographs from friends and family.)
- SWWS does not include paintings of nudes.
- SWWS reserves the right to refuse any painting not meeting prospectus requirements.

ENTRY FEE:

 \$20 for first painting, plus \$10 each for second, third and fourth paintings.

FRAMING & MATTING REQUIREMENTS:

- All paintings must be matted and framed, except canvas or cradle board (see below).
- All matted work to be protected by Plexiglas (acrylic). Glass is not permitted.
- · Mat and Plexiglas must be clean.
- Frames must be two (2) inches wide or less.
- Only plain and neutral frames will be allowed.
- Maximum outside frame dimensions: 34 x 42 inches
- Triptych and diptych paintings must conform to the maximum dimensions as a whole painting.
- Limit of 25 pounds for completed artwork, frame included.
- Mats must be either white or off-white. No colored mats.
- Liner: One (1) colored liner, maximum one-half inch (1/2")
- Cradle-mounted work must be no greater than two inches deep, with a finished edge, and be protected by a transparent coating.
- Paintings must be ready to hang with D-ring style hangers attached to the frame down 1/3 the distance from the top.
- Taut plastic-coated picture wire must be attached to the frame.
 Unacceptable: Screw eyes, saw tooth hangers, clips, electrical wire or uncoated metal wire.

PAINTING REQUIREMENTS:

- Each artist may submit four (4) paintings. One may be a full sheet and the other three must be half-sheets or smaller. You will be notified if we do not have room to hang all of your entries.
- All entries must be on an acid-free surface (for example: watercolor paper, Yupo, canvas or cradle board). The only acceptable collage material is original water-media on paper and executed by the artist.
- Printed and/or computer generated material is not acceptable.
- A photo taken before the painting is framed is suggested and would be helpful for possible use by SWWS during the awards ceremony and in our newsletter, or by Boomerang for publicity purposes. DO NOT submit photos with your registration. You will be asked for them if they are needed.
- While those handling the show will take every precaution, SWWS will not assume responsibility for loss or damage to paintings.
- By entering the show, the artist gives SWWS the right to use printed and electronic images of the paintings for SWWS promotional and educational purposes only, including but not limited to, the SWWS website, brochures, and press releases.

SALES:

- A 30% commission will be charged by SWWS on all painting sales transactions conducted during or within 30 days of show exposure.
- Washington State sales tax of 8.4% will be added to the selling price and paid to the State by Boomerang which will be conducting sales.
- You will be notified if your painting is sold. If so, you will receive payment from SWWS within 30 days.
- You may indicate that your painting is "Not for Sale" by entering NFS on your show registration form.

CONDITIONS:

- Paintings must remain on display until close of show.
- Buyers will be asked to collect their purchases on the last day of the show, Oct. 27 from 8 a.m. to 9 p.m.

PICK UP PAINTINGS:

• Oct. 28, 10 a.m.–12 noon. If you cannot pick up your art during this time frame, please provide your paperwork to a substitute.
