A “Prospectus” is defined as a printed document that advertises or describes a school, commercial enterprise, forthcoming book, etc., in order to attract or inform clients or members.

SWWS utilizes a Prospectus to inform our members of an upcoming show event which has established certain rules for participation. In the past, these rules have been created or adopted by our members in leadership roles as minimal standards for participation in a sanctioned and juried art show. We print these “rules” and ask you to sign that you have read them before every show.

And yet . . . there is confusion!

How wide can a frame be? Can it have bumps and scrolls on it?

What color should the mat be?

How many and how big can a liner be? What is a liner?

What type of hanging hardware must I have? Is a sawtooth hanger OK?

How far from the top of my art should my wire be

placed? Why does it have to be coated?

You may be surprised to know that five participants in our Spring show made one or more mistakes when they checked in their beautiful art. This situation is awkward for the staff receiving your work. They have to check with other members and decide what to do . . . either 1) refuse your art, or . . . 2) stretch the rules. No one wants to send you away disappointed or upset, but remember that when others follow the rules they are equally upset that you did not! What if you win a prize and then it is mentioned that the art piece did not comply with the rules.

It is my suggestion that each person needs to read the current prospectus before each and every show. Few things are ever changed but once in awhile they do, and if they do, you need to be sure you read it and comply.

With another show coming up in late September, we hope you are painting with gusto. Just be sure you are ready to sign the Registration Form where it says:

**Yes, all of my entries meet the 2019 SWWS Prospectus criteria. Artist signature \_\_\_\_\_.**

## Fall Jury-In Opportunity for Associate Members

The opportunity for associate members to Jury into full active membership is coming Tuesday, September 17, 2019 in time for you to enter the Fall Show September 29 this year in the juried category. Associates wishing to be juried need to submit three paintings, two of which must be transparent watercolor. The other submission may be either transparent watercolor or water media. All paintings must be framed except for cradle boards, but they do not have to meet the precise framing requirements for the show.

Paintings must have been executed within the past two years. All paintings must be the original work of the submitting artist: no copies or likenesses of other artists' or photographers' works. This includes, but is not limited to, images from books, magazines, calendars, greeting cards, catalogs, and the internet. Exception is made for use of photographs from friends and family.

If you are interested in registering for jurying in, contact Barbara Hope by Friday, September 6th via email at [hopeartwatercolors@gmail.com](mailto:hopeartwatercolors@gmail.com) (preferred) or by phone at 209-985-8685. You will be sent the forms and any other information you need for submission, including where to bring your paintings.

Paintings need to be delivered, Friday, September 13th between 10:00 a.m. and 1:00 p.m. At that time, you will need to bring your filled-out application forms and pay the \$10.00 jury fee (CHECK ONLY), which is refunded if you are not juried in.

On Tuesday, September 17th, five judges will meet to evaluate the submissions. At pick up, a letter will be given to you advising of the results. You can pick up your paintings on Friday, September 20th between 10:00 a.m. and 1:00 p.m.

When the jury panel meets to consider submissions, it follows a list of artistic criteria, including:

**Technique:** Is the artist demonstrating knowledge of watercolor techniques and competence in using them—blending, wet on wet, wet on dry, texture, brush strokes, glazing, lost edges, and more. The Jury panel is looking for some diversity of technique. (Note that you might be using a very limited number of these techniques on a given painting, depending on your subject and what you are trying to achieve, and that's fine.)

**Composition:** Does the composition lead the eye of the viewer through the painting to the center of interest?

**Subject Matter:** Does the artist show knowledge of the subject matter? Is the subject matter well drawn?

**Color, Value:** Does the artist demonstrate an understanding of color theory? Do colors work together to express the appropriate feeling or mood? Are there a variety of values? Are values used to lead the eye?

1. Provide your biography in a Word document. Please limit it to 250 words/1400 characters w/spaces.
2. At the end of your bio, please list the names of your paintings as you want them to appear on your web page.
3. Please indicate which of your paintings you would like shown under your name as a profile picture on the “SWWS Members Page.”
4. Send up to eight photos of your paintings to be displayed on your member page.
5. Send a photo of yourself.

## PHOTO REQUIREMENTS

When you are saving your photos, the dimensions should be no larger than 1000 pixels on the longest side. Please save this image at a resolution of 72 pixels/inch. Be sure to name the file so the webmaster can label properly.

Save your image files as “.jpg”.


It is important that the name you use when saving your image file is the same name you use in your Word document when listing the titles of each painting you are showing. ONLY letters and numbers and “\_” underscore may be used in the image file name. Do not use special characters ?, >, <, “, ‘, &, %, etc.

### ELIGIBILITY:

- SWWS juried and associate members who have paid their current dues.
- Watercolor or watermedia paintings must have been created within the past two (2) years and not previously shown at an SWWS show.
- Paintings must be original work of the submitting artist. No copies or likenesses of other artists' or photographers' works are acceptable. (NOTE: This includes, but is not limited to, images from books, magazines, calendars, greeting cards, catalogs, and the internet. Exception is made for the use of photographs from friends and family.)
- Paintings of nudes must be pre-approved by a Board committee. PLEASE REQUEST APPROVAL AT TIME OF SHOW ENTRY.
- SWWS reserves the right to refuse any painting not meeting prospectus requirements.

### ENTRY FEE:

- \$20 for first painting, plus \$10 each for 2nd and 3rd paintings.

### FRAMING & MATTING REQUIREMENTS:

- All paintings must be matted and framed, except canvas or cradle board (see below).
- All matted work to be protected by Plexiglas (acrylic). Glass is not permitted.
- Mat and Plexiglas must be clean.
- Frames must be two (2) inches wide or less.
- Only plain and neutral frames will be allowed.
- **Maximum outside frame dimensions: 34 x 42 inches**
- Triptych and diptych paintings must conform to the maximum dimensions as a whole painting.
- Limit of 25 pounds for completed artwork, frame included.
- Mats must be either white or off-white. No colored mats.
- Liner: One (1) colored liner, maximum one-half inch (1/2")
- Cradle-mounted work must be no greater than two inches deep, with a finished edge, and be protected by a transparent coating.
- Paintings must be ready to hang with D-ring style hangers attached to the frame down 1/3 the distance from the top.
- Taut plastic-coated picture wire must be attached to the frame.  
**Unacceptable:** Screw eyes, saw tooth hangers, clips, electrical wire or uncoated metal wire.

### PAINTING REQUIREMENTS:

- Each artist may submit three (3) paintings. One may be a full sheet and the other two must be half-sheets or smaller.
- Paintings of nudes must be pre-approved by a Board committee. Please enter early and request approval.
- All entries must be on an acid-free surface (for example: watercolor paper, Yupo, canvas or cradle board). The only acceptable collage material is original water-media on paper and executed by the artist.
- Printed and/or computer generated material is not acceptable.
- **A photo taken before the painting is framed is suggested and would be helpful for possible use by SWWS or publicity purposes. DO NOT submit photos with your registration. You will be asked for them if they are needed.**
- While those handling the show will take every precaution, SWWS will not assume responsibility for loss or damage to paintings.
- By entering the show, the artist gives SWWS the right to use printed and electronic images of the paintings for SWWS promotional and educational purposes only, including but not limited to, the SWWS website, brochures, and press releases.

### SALES:

- A 30% commission will be charged by SWWS on all painting sales transactions conducted during or within 30 days of show exposure.
- Washington State sales tax of 8.4% will be added to the selling price and paid to the State by Vancouver Art Space who will be conducting sales.
- You will be notified if your painting is sold. If so, you will receive payment from SWWS within 30 days.
- You may indicate that your painting is "Not for Sale" by entering NFS on your show registration form.

### CONDITIONS:

- **Paintings must remain on display until close of show.**
- **Buyers will be asked to collect their purchases on the last day of the show, October 27th prior to take down at 2 p.m.**

### PICK UP PAINTINGS:

- October 27th, 2-4 p.m.
- If you cannot pick up your art during this time frame, please provide your paperwork to a substitute.


